# 1.3 PREBID MEETING

A. Prebid Meeting: A Prebid meeting for all bidders will be held at Champaign Centennial High School, Room TBD on March 19, 2024 at 3:45 p.m. local time. Check-in at east visitor entrance. Prospective prime bidders are requested to attend.

#### 1.4 PREVAILING WAGE

A. This contract calls for the construction of a "public work," within the meaning of the Illinois Prevailing Wage Act (820 ILCS 130/0.01 et seq.) ("the Act"). The Act requires contractors and subcontractors to pay laborers, workers and mechanics performing services on public works projects no less than the "prevailing rate of wages" (hourly cash wages plus fringe benefits), in the county where the work is performed. For information regarding current prevailing wage rates, please refer to the Illinois Department of Labor's website at http://www.illinois.gov/idol/Laws-Rules/CONMED/Pages/prevailing-wage-rates.aspx. Contractor and Subcontractors shall include in bids, the cost for the current prevailing wage (Illinois Prevailing Wage Act - 820 ILCS 130/0.01 et seq.). The Contractor shall ensure that any Subcontractors shall comply with the Illinois Prevailing Wage Act.

#### 1.5 BID SECURITY

- A. A bid bond, bank draft, or certified check made payable to the Champaign CUSD #4 in the amount of five percent (5%) of the Base Bid proposal shall accompany each bid as a guarantee that the Bidder, if awarded the Contract, will furnish satisfactory Performance Bond, Labor and Material Payment Bond, in the amount of one hundred percent (100%) of the contract sum, execute the Contract and proceed with the Work. Upon failure to do so, he shall forfeit the deposit or amount of bid bond as liquidated damages, and no mistakes or errors on the part of the Bidder will excuse the Bidder or entitle him to a return of the deposit or bid bond. No Bidder may withdraw his bid for a period of 45 days after the date of opening thereof. The bid bonds or checks will, with the exception of those of the three lowest bidders, be returned seven days after the opening of bids and the remaining checks or bid bonds will be returned when the Contract is executed and bond provided.
- B. The successful bidders will be required to furnish a Performance Bond and Labor and Material Payment Bond in form and Surety as specified and in the full amount of the contracts. Cost of such bonds shall be included in the Bidder's Proposal.

### 1.6 MINORITY/WOMEN BUSINESS ENTERPRISE

A. It is the intent of Champaign Community School District Unit #4 to utilize Minority and Women Business Enterprises (MBE/WBE) in the construction of the school facilities in the District. In this regard, the District encourages minority and female participation as Prime Contractors, as well as for Prime Contractors to utilize available resources to identify such businesses, and recruit them to work as Subcontractors and suppliers on the Project. The District's target goal is 12% MBE and 8% WBE participation. Other pertinent information applicable to the form of the Bid, the manner of its submission, and the documents which must accompany it are included in the Specifications and other Contract Documents.

#### 1.7 BACKGROUND CHECKS

A. Each employee on Champaign Unit 4 School District premises will be required to undergo a background check prior to commencing work. Champaign Unit 4 School District's "Contractor-Vendor Background Check Packet" is bound into the supplementary general conditions.
