## 1.1 PROJECT INFORMATION

- D. Project Description: Project consists of removing existing ballasted single ply membrane roofing and all existing insulation on three smaller roofs of Urbana Middle School. Roof areas are approximately 5,300 base bid and two alternates of 5,210 for a total of 10,510 square feet. In addition, approximately 145 linear feet of base flashing is to be replaced at surrounding roofs. New insulation will be installed and a new fully adhered TPO membrane will be installed along with required flashing and roof edge.
  - 1. Project cost range is anticipated to be \$100,000 to \$150,000.
- E. Construction Contract: Bids will be received for the following Work:

- B. Bids will be thereafter publicly opened and read aloud. The District will follow social distancing guidelines and have limited attendance at the Bid opening at the District office.
- C. The Board of Education reserves the right to reject any or all bids or any part thereof, to waive any informalities and irregularities in the bidding and to accept the bids deemed most favorable to their interest, after all bids have been examined and evaluated.

## 1.3 BID SECURITY

A. A bid bond, bank draft, or certified check made payable to the Urbana School District #116, Urbana, Illinois in the amount of ten percent (10%) of the Base Bid proposal shall accompany each bid as a guarantee that the Bidder, if awarded the Contract, will furnish satisfactory, execute the Contract and proceed with the Work. Upon failure to do so, he/she shall forfeit the deposit or amount of bid bond as liquidated damages, and no mistakes or errors on the part of the Bidder will excuse the Bidder or entitle him/her to a return of the deposit or bid bond. No Bidder may withdraw his/her bid for a period of 45 days after the date of opening thereof. The bid bonds or checks will, with the exception of those of the three lowest bidders, be returned seven days after the opening of bids and the remaining checks or bid bonds will be returned when the Contract is executed.
