

NOTICE TO BIDDERS

Notice is hereby given that Huntington County, by and through its Board of County Commissioners, will receive sealed bids for the construction of :

Replacement of Bridge No. 49, County Road 200 West over Majenica Creek Lancaster Township Huntington County, Indiana

Sealed proposals will be received at the Auditor's Office, 201 N. Jefferson Street, Room 103, Huntington, IN, until 8:30 a.m. on July 28, 2014. All proposals will then be publicly opened and read aloud at the County Commissioner's Meeting at 9:00 a.m. Bids received after the 8:30 a.m. deadline will not be considered but will be returned to the bidder unopened. Only proposals from those CONTRACTORS who are registered on the Indiana Department of Transportation's current listing of Prequalified Contractors for item D(B) "Bridges: Highway Over Highways" will be considered. Any bids submitted by CONTRACTORS not approved for this item on the list will be returned to the bidder unopened.

The work to be performed and the proposals to be submitted shall include a bid for all general construction, labor, material, tools, equipment, taxes, permits, licenses, insurance, service costs, etc. incidental to and required for this project.

All materials furnished and labor performed incidental to and required by the proper and satisfactory execution of the contracts to be made, shall be furnished and performed in accordance with requirements from the drawings and specifications included in these documents. Plans, Specifications and bidding documents may be obtained from Eastern Engineering upon the payment of \$50.00 for each set. These sets may include full-size drawings. Payment must be by check or money order and shall be made payable to United Consulting. NO CASH ACCEPTED. All payments and costs of Contract Documents are non-refundable. Each proposal must be enclosed in a sealed envelope with the supplied sealed bid notice, bearing the title of the project, bid opening date and the name and address of the bidder firmly attached. The proposal shall be accompanied by a certified check or acceptable ***Bidder's Bond***, made payable to Huntington County, in a sum of not less than ***ten percent*** of the total amount of the proposal, which check or bond will be held by the said Huntington County as evidence that the bidder will, if awarded a contract, enter into the same with the *OWNER* upon notification from him to do so within ten days of said notification. Failure to execute the contract and to furnish performance bond to Huntington County, will be cause for forfeiture of the amount of money represented by the certified check, or bidder's bond, as and for liquidated damages. Form 96, as prescribed by the Indiana State Board of Accounts, shall be properly completed, and submitted with bid proposals.

The Board of Commissioners reserves the right to reject any or all proposals, to waive technicalities or irregularities therein, to delete any item or items and to award a contract on the proposal that in their judgment is the most advantageous to Huntington County.
