The fifty-dollar (\$50.00) fee includes a hard copy. Upon purchase of a hard copy an electronic download will be available from Eastern Engineering for an additional fee. Contact Eastern Engineering Supply at (317) 598-0661 to obtain a Job Order Form. Submit a request, by mail or fax, including your company name, address, phone/fax number, and the project name(s), with a check payable to **STR Building Resources LLC**.

The bids must also be accompanied by a certified check, cashier's check, money order or a satisfactory Bid Bond executed by the bidder and an acceptable surety company, as required; made payable to the Owner for not less than five percent (5%) of the total bid price and delivered in a sealed opaque envelope showing the Bidder's name and address.

Owner reserves the right to accept or reject any bid or waive any informality or errors in bidding for a period of sixty (60) days from bid date. It is Owner's intent to award contracts within thirty (30) days. Should Bidder withdraw his/her bid within sixty (60) days after bid date without written consent of Owner, or fail to execute a satisfactory contract, including Performance Bond, within ten (10) days after written notice of acceptance of Bid, Owner may declare the Bid Security forfeited as liquidated damages, not as penalty.

Successful Bidder shall furnish an approved Performance Bond, Labor and Material Payment Bond in an amount equal to one hundred percent (100%) of the Contract Amount, with an approved surety company and said Bond shall remain in full force and effect for a period of twelve (12) months after date of acceptance of Work. Bond shall be furnished at time of written notice to proceed with Work.

All prime contractors submitting bids on Projects shall encourage qualified minority subcontractors to perform any portions of Work in Project not performed by Contractor's own forces. Bidders must submit written evidence that quotations have been solicited from qualified minority subcontractor at the time Bidder submits his/her bid to Tippecanoe School Corporation for all portions of Work in the projects which the Bidder is not proposing to perform with his/her own forces.
