Sealed Proposals for the Newton County Bridgeman Tile Access Points Project will be received by the Drainage Board of Newton County, State of Indiana, c/o the Surveyor of Newton County ("Owner"), at 310 N Second St., P.O. Box 126, Kentland, IN 47951, until _12:00_ P.M., local time, on November _5_, 2018 at which time the Proposals will be publicly opened and read. Each Proposal should be clearly marked "PROPOSAL ENCLOSED for Bridgeman Tile Access Points Project" on the outside of the envelope. Proposals received after that time will be returned unopened. A conditional or qualified Proposal will not be accepted.

The Project, which is locally funded, will be constructed in one (1) contract division. In general, the work consists of providing all labor and material for the creation of 5 access points to the Bridgeman Tile, located on County Road S 350 W in Kentland, IN:

- Excavation of approximately 50 feet of the existing Bridgeman Drainage tile(s)
- Saw cutting (5) 32" long access points in the existing Bridgeman Drainage tile(s)
- Installation of 5 hand hole boxes
