Sealed bids will be received by the Darlington Town Council at the Darlington Municipal Utilities building, 222 W. Main St., P.O. Box 578, Darlington, Indiana 47940 until Friday May 11, 2018 at 2:00 p.m. E.D.T. for the following:

### **Darlington Covered Bridge Rehabilitation On County Road 600 East Over Sugar Creek Montgomery County, Indiana**

Bids will be publicly opened and read aloud at a Town Council meeting in the Darlington Community Center on May 15, 2018. Bids received after May 11, 2018 at 2:00 p.m. EDT will be returned unopened. Bids received by facsimile machine will not be accepted. Only bids from those Contractors who are registered on the Indiana Department of Transportation's current listing of Prequalified Contractors for this type of work included in this project will be considered. Contractors must also have and be able to provide proof of at least 5 years of experience with work on Historic Timber Covered Bridges.

Construction shall be in accordance with the bidding documents which are on file with the Town Municipal Department. Said documents may be examined by prospective bidders at the following locations:

Bid Documents: All bids shall be accompanied by (1) Bid Form included in the bidding documents (2) completed Form 96 (Ind. State Board of Accounts - Rev.) with required attachments (3) Non-discrimination affidavit as required by the laws of the State of Indiana, and (4) Bid security, as described below (5) Other bidding documents as described in the instructions to bidders.

Bid Security: Bid Security in the amount of five percent (5%) of the Bid shall accompany each Bid. Bid Security may be in the form of a Bid Bond (A-310), certified check or cashier's check. If the Bidder withdraws a bid within sixty (60) days after the opening date, without consent of the Owner or fails to execute a satisfactory contract within ten (10) days after notice of acceptance, the Owner may declare the Bid deposit forfeited as liquidated damages.

Bonds: The successful Bidder will be required to furnish Performance and Payment Bonds for 100% of the Contract Sum.

The Owner reserves the right to accept or reject any Bid and to waive any irregularities in the bidding. All bids may be held for a period not to exceed 60 days, or as otherwise stated in the

Contract Documents before awarding the contract.
