All Proposals must be accompanied by a satisfactory Bid Bond executed by the Bidder and an acceptable surety company, a certified check, money order or cashier's check made payable to the Owner for not less than five percent (5%) of the total bid price and delivered in a sealed opaque envelope referencing the Bidder's name and address.

CONTRACT AWARD

- A. The project is intended to be let as Three (3) Prime Contract Bids. Base Bid and Alternate Add Bids shall be submitted as described in the Bidding Documents.
- B. The Owner reserves the right to accept or reject any and/or all Bids, and/or waive any informalities or errors in Bidding for a period of sixty (60) days from the Bid receipt date. It is the Owner's intent to award contracts within thirty (30) days after Bid receipt.
 - 1. The Owner may declare the Bid Security forfeited as liquidated damages (not as a penalty) if the Bidder:
 - a. Withdraws his Proposal within sixty (60) days after Bid receipt without written notification to, and consent by the Owner;
 - b. Fails to execute a satisfactory contract, including required Bonds, within ten (10) work days after written Notice to Proceed with the Work has been received.
- C. The successful Bidder(s) shall furnish an approved Performance Bond and Labor and Material Payment Bond in an amount equal to one hundred percent (100%) of the Contract Amount. Said Bond shall remain in full effect and force for a minimum period of twelve (12) months after date of acceptance of the Work.
