

**ADVERTISEMENT FOR BIDS

2018 STREET RESURFACING PROJECT**

Sealed Bids for the Town of Amo, Indiana, 2018 Street Resurfacing Project, will be received by the Town of Amo (Owner) at the office of Kieser Consulting Group, LLC., located at 9120 Otis Ave., Suite 103, Lawrence, Indiana 46216, between the hours of 8:00 AM and 4:00 PM, (Local Time), on Dec. 7, 2017; at 7:00 PM, on Dec. 7, 2017, the Bids will be publicly opened and read at the Town of Amo, Community Building located at 5046 Sycamore Street, Amo, Indiana 46103. Each Bid should be clearly marked "BID ENCLOSED FOR TOWN OF AMO, INDIANA, 2018 STREET RESURFACING PROJECT" and the bidders name and address on the outside of the envelope. Bids submitted after that time will be returned to the bidder unopened. A conditional or unqualified Bid will be rejected.

The Base Bid will include milling, resurfacing, ADA curb ramps and in the following areas; North Vine Street, from Church Street to West School Street, and Mobilization/Demobilization for all. This project is proposed for spring 2018.

The Project, which is funded from Town funds and a Community Crossings Grant, will be constructed in up to one (1) contract division. In general, the work consists of providing all labor and material for the project.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids. All bids received shall remain valid and in force for 60 calendar days after the date of Bid opening.

The Owner reserves the right to reject any and all Bids in whole or in part as specified in the solicitation when it is not in the best interest of the governmental body as determined by the purchasing agency in accordance with IC 5-22-18-2. The Owner also reserves the right to waive irregularities in any Bid, and to accept any Bid, which is deemed most favorable to the Owner.
