

NOTICE TO BIDDERS

Notice is hereby given that sealed proposals will be received by the Board of Public Works and Safety of the City of Richmond, Indiana in the office of Purchasing in the Municipal Building of said City until the hour of 4:59 p.m. on the day of July 27, 2017 for furnishing the following in accordance with specifications on file in the office of Purchasing in the Municipal Building, Richmond, Indiana.

Blight Elimination Program (BEP) Demolition-Round 1 Bid 6 and Round 2 Bid 5

All proposals shall be properly and completely executed on Form No. 96 as prescribed by the State Board of Accounts of the State of Indiana. All proposals submitted shall be accompanied by an acceptable Bidder's Bond, Certified Check or Cashier's Check made payable to the City of Richmond, Indiana in the amount of 5% of the total bid price. If the bidder is from out-of-state, the Bidder's Bond must be secured by a Surety who is admitted to do business in Indiana. The successful bidder will be required to submit a Performance Bond in the amount of 100% of the bid price and a 100% Labor and Materials Payment Bond prior to commencing work. Checks of the unsuccessful bidders will be returned on award of the proposal. Specifications and bid forms may only be obtained from the online plan room <distribution.easternengineering.com>. All proposals should be placed in a sealed envelope marked "Confidential Bid Proposal – BEP Demolition" on outside of envelope.

This Work will be funded by the Blight Elimination Program funds via the US Treasury awarded to the City of Richmond. Good faith efforts will be made and reasonable steps taken to include Minority Business Enterprise (MBE), Disabled Business Enterprise (DBE), Women Business Enterprise (WBE), Veteran Owned Small Business (VSOB) and Service Disabled veterans Owned Small Business (SDVOSB) for this contract. Bidder will be required to comply with all applicable Equal Employment Opportunity laws and regulations, including Section 504 of the Rehabilitation Act of 1983.

A pre-bid meeting will be held on June 28, 2017 at 10:00 a.m. in the Community Room, 2nd floor of the Richmond Municipal Building, 50 North 5th Street, Richmond, IN 47374. All prospective bidders are strongly urged to attend the pre-bid meeting as no other meeting will be held.
