Contractors shall note that this project is subject to Indiana's regulations for public works construction contractors per the repealed Common Construction Wage Act (effective July 1, 2015) for record keeping and all terms described in Section 007375 and shall be followed in their entirety.

Contractors shall note that this project will require the inclusion of a 100% Performance Bond as part of their bid.

Each bidder is responsible for inspecting the project site and for reading and being thoroughly familiar with the Contract Documents and Specifications. The failure of omission of any part or portion of the Contract work by a Bidder shall in no way relieve them from any Contract obligation with respect to their Bid. A submission of a Bid implies that the Bid is the Contractor's representation of the Cost of Work and is sufficient to allow the Contractor to fulfill all Contract Obligations to construct the work described in the Contract Documents and Specifications.
