BETHEL & HATHAWAY IMPROVEMENTS 2018**

ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **Bethel & Hathaway Improvements 2018** will be received by the **Town of Huntertown**, at the office of the **Huntertown Town Hall, 15617 Lima Road, Huntertown, IN 46748**, until **2:00 p.m.** local time on **Tuesday December 11, 2018**, at which time the Bids received will be publicly opened and read in the **Huntertown Town Hall, 15617 Lima Road, Huntertown, IN 46748**. The Project limits are generally Hathaway Road from the bridge over Geller Ditch to Lima Road and Bethel Road from Carroll Road to Boulder Pass/Crooked Cove. The work on Hathaway Rd. includes, but is not limited to: full depth reclamation (FDR) with a double chip & seal wearing course, drainage improvements, linear grading, mulched seeding, and pavement markings. The work on Bethel Rd. includes but is not limited to: partial full depth reconstruction with the remaining pavement being milled & resurfaced with isolated full depth pavement patching areas, linear grading, mulched seeding, and pavement markings.

The project has two bid packages: Bid Package #1 – Hathaway Road Full Depth Reclamation; and Bid Package #2 – Bethel Road Improvements. Bidders are not required to submit Bids for both bid packages. Bid Package #1 has three add alternate bids.

Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of **8:00 a.m. to 5:00 p.m.** and may obtain copies of the Bidding Documents from the Issuing Office as described below. Reproduction costs to be paid by prospective bidders.

A pre-bid conference will be held at **10:00 a.m.** local time on **Tuesday December 4, 2018** at the **Huntertown Town Hall Conference Room**. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Instructions to Bidders.

Certification of Qualification Required: Copy of Valid Certificates of Qualification for Public Works Projects per IC 4-13.6-4 or IC 8-23-10 as Applicable. Required Only for Contract Award Greater Than or Equal to \$300,000. Applies to all contractor tiers as defined by IC 5-16-13. Excludes suppliers as defined by IC 4-13.6-1-20.

The Huntertown Town Council reserves the right to reject all bids, waive defects, and amend the Project's scope. It is anticipated that the Town Council will take bids received under advisement and that a determination may be made at the Huntertown Town Council December 17, 2018 meeting.
