Contractors shall note that this project is subject to the Common Construction Wage Act (effective July 1, 2015) for record keeping and all terms of this Act shall be followed in their entirety.

Contractors shall note that this project will require the inclusion of a 100% Performance Bond as part of their bid.

Each bidder is responsible for inspecting the Project site and for reading and being thoroughly familiar with the Contract Documents and Specifications. The failure of omission of any Bidder to do any of the foregoing shall in no way relieve any Bidder from any obligation with respect to their Bid.
