ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **County Road 21 Project** will be received by **DeKalb County**, at the office of the **DeKalb County Commissioners**, until **10:00 a.m.** local time on **Monday April 23, 2018**, at which time the Bids received will be publicly opened and read **in the Commissioner's meeting room in the DeKalb County Courthouse**. The Project shall consist the construction of a new roadway alignment for County Road 21 and the widening of S.R. 8 for a right-turn lane. The work includes, but is not limited to: pavement and curb demolition, guardrail removal and replacement, tree removal, fence removal, topsoil stripping, earthwork, erosion control, soil stabilization, asphalt pavement, concrete curb, sidewalk, and driveway approaches, pavement markings, traffic control, sanitary sewer, storm sewer removal and replacement, water main, fire hydrants, and fittings, special backfill, street lighting, and seeding.

Bids will be received for a single prime Contract. Bids shall be on a unit price basis, with additive alternate bid items as indicated in the Bid Form.

A pre-bid conference will be held at **10:00 a.m.** local time on **Monday April 9, 2018** at the **DeKalb County Commissioner's meeting room in the DeKalb County Courthouse**. Attendance at the pre-bid conference is highly encouraged but is not mandatory.

Bid security shall be furnished in accordance with the Instructions to Bidders.

Certification of Qualification Required: Copy of Valid Certificates of Qualification for Public Works Projects per IC 4-13.6-4 or IC 8-23-10 as Applicable. Required Only for Contract Award Greater Than or Equal to \$300,000. Applies to all contractor tiers as defined by IC 5-16-13. Excludes suppliers as defined by IC 4-13.6-1-20.

The DeKalb County Commissioners reserves the right to reject all bids, waive defects and amend the Project's scope. It is anticipated that the DeKalb County Commissioners will take bids received under advisement and that a determination may be made at the DeKalb County Commissioners April 30, 2018 meeting.
