Turpin High School – Pre-Bid Walk Thru March 19, 2024

The following items were discussed at the Pre-Bid Walk Thru on March 19, 2024 and should be considered ADDENDUM's to the Bid Documents:

1. The stage lighting integrator is to include an Ohio Licensed Electrical Contractor as part of their services.
2. The project Electrical Contractor shall “trace and label/number” all existing stage lighting circuits at both the raceways and circuit boxes as required.
3. Removal of the existing stage lighting fixtures is to be provided by the Stage Lighting Integrator. The fixtures are to be stored on stage as directed by the Owner. Removal from the site will be by the Owner.
4. There (5) existing Elation Fuze Profiles that should be installed, circuited, focused, and programmed as part of the stage lighting fixture installation scope of work.
5. Discarding of all cardboard and packaging associated with the new stage lighting system is by the Owner.
6. Dumpsters will be provided by the Owner.
7. Project schedule assumes approximately 12-week lead time and 4-week installation. Approval of the project will be provided upon approval by the School Board (meeting April 17).
