# 1.3 BID SECURITY

A. Bid security shall be submitted with each bid in the amount of ten (10) percent of the bid amount. Security may be supplied as certified check, cashier's check or Bid Bond for ten (10)

percent of the base bid plus all additive Alternate bids payable to Eastern Hancock Schools.

B. No bids may be withdrawn for a period of sixty (60) days after opening of bids. Owner reserves the right to reject any and all bids and to waive informalities and irregularities.

- A. Bidders must be in compliance with Indiana statues regarding pre-qualification.
- B. Bidders must be properly licensed under the laws governing their respective trades and be able to obtain insurance and bonds required for the Work. A Performance Bond, a separate Labor and Material Payment Bond, and Insurance in a form acceptable to Owner will be required of the successful Bidder.
- C. 110% performance and payment bonds will be required from successful bidders. Bonds shall be made only with approved surety companies and said bonds shall remain in force and effect for a period of twelve (12) months from the date of completion and acceptance of the longest guarantee provided under the contractor's contract.
