

**ADVERTISEMENT FOR BIDS

2026 STREET RESURFACING PROJECT**

Sealed Bids for the Town of Orestes, Indiana, 2026 Street Resurfacing Project, will be received by the Town of Orestes (Owner) at the Orestes Town Hall located at 14 E. Oak Street, Orestes, IN 46063, on February 4, 2026, from 9:00AM to 11:00AM; on February 4, 2026, at 11:01AM, the bids will be publicly opened and read at the Town Hall, located at 14 E. Oak Street, Orestes, IN 46063. Each Bid should be clearly marked "BID ENCLOSED FOR TOWN OF ORESTES, INDIANA, 2026 STREET RESURFACING PROJECT" and the bidders name and address on the outside of the envelope. Bids submitted after that time will be returned to the bidder unopened. A conditional or unqualified Bid will be rejected.

The Base Bid will include milling, resurfacing, ADA curb ramps, mobilization and demobilization, in the following areas; Leota St., from Oak St. to 2<sup>nd</sup> St., E. 1<sup>st</sup> St. – From 380 ft. east of Michigan St. (Main St.) to Prospect St., W. 1<sup>st</sup> St., from Leota St. to Superior St., and 2<sup>nd</sup> St., from Leota St. to Superior St.

The Project, which is funded from Town funds and a Community Crossings Grant, will be constructed in up to one (1) contract division. In general, the work consists of providing all labor and material for the project.

Any Bid may be withdrawn prior to the scheduled closing time for receipt of Bids. All bids received shall remain valid and in force for 60 calendar days after the date of Bid opening.

The Owner reserves the right to reject any and all Bids in whole or in part as specified in the solicitation when it is not in the best interest of the governmental body as determined by the purchasing agency in accordance with IC 5-22-18-2. The Owner also reserves the right to waive irregularities in any Bid, and to accept any Bid, which is deemed most favorable to the Owner.
