E. Project Description: Relocation of existing diesel generator from Highway Garage to Youth Services Bureau, installation of new diesel generator at Highway Garage, and installation of associated concrete equipment pads, transfer switches, conductors, raceways, and other electrical equipment.

F. A mandatory Pre-Bid Site Tour will be held on 01-28-2026 at 10:00 AM local time, meeting at the Monroe County Highway Department Garage, 5900 W. Foster Curry Dr., Bloomington, IN. The group will travel to the Youth Services Bureau from there. Failure to attend may result in rejection of any offer submitted at Owner's discretion.

G. The intent is for this project to be contracted as a single, prime contract.

I. Bidders will be required to provide Bid security in the form of a Bid Bond of a sum no less than 10 percent of the Bid Amount.
