2.02 MATERIALS

- A. Adhesives Used for Assembly: Comply with VOC requirements for adhesives and sealants as specified in Section 01 6116.
- B. Wood-Based Materials:
 - 1. Solid Wood: Air-dried to 4.5 percent moisture content, then tempered to 6 percent moisture content before use.
- C. Solid Wood: Clear, dry, sound, plain sawn, selected for species grain and color, no defects.
- D. Particleboard: Composed of wood chips, medium density, with waterproof resin binders; of grade to suit application; sanded faces; complying with ANSI A208.1.
- E. High Pressure Decorative Laminate (HPDL): NEMA LD 3, types as recommended for specific applications, complying with Grade requirements, and standard with the manufacturer.

2.03 FABRICATION

- A. Shop assemble casework for delivery to site in units easily handled and to permit passage through building openings.
- B. Fabricate corners and joints without gaps.
- C. Fabricate each unit to be rigid and not dependent on adjacent units for rigidity.

PART 3 EXECUTION

3.01 EXAMINATION

A. Verify adequacy of support framing.

3.02 INSTALLATION

- A. Install casework, components and accessories in accordance with manufacturer's instructions.
- B. Use anchoring devices to suit conditions and substrate materials encountered.
- C. Set casework items plumb and square, securely anchored to building structure.

3.03 ADJUSTING

A. Adjust doors, drawers, hardware, and other moving or operating parts to function smoothly.

3.04 CLEANING

A. Clean casework, countertops, shelves, and hardware.

3.05 PROTECTION

A. Do not permit finished casework to be exposed to continued construction activity.
