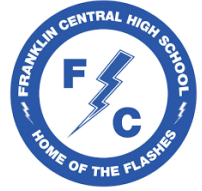

TRACK RENOVATIONS AT FRANKLIN CENTRAL HIGH SCHOOL

BASE BID, comprises all existing track-coated surfaces within the existing 8-lane track configuration (and east D-zone), including milled/resurfaced asphalt, latex track coatings, lane striping/markings, replacement fencing, and "apron" pavement below fencing on the east end of the track. Note that existing pole vault and long jump runways east of the stadium shall simply be rebuffed rather than milled. Price shall be lump sum.

ALTERNATE BID

Alternate #1 – Upgrade to Polyurethane Track Coatings: Provide the differential cost to upgrade from Latex coatings to Polyurethane coatings on the current, unmodified track layout. Bidder shall assume within this Alternate Bid that existing asphalt surface will remain without mill/resurface efforts. Remove existing latex coatings, then prepare existing asphalt to receive polyurethane coatings. All other scope items are unchanged. Price shall be lump sum.

ALTERNATE BID

Alternate #2 – Expand Extents of Track: Provide the differential cost to expand the paved extents of the track as shown on the northwest, northeast, and southwest corners of the facility. Include all site preparation, grading, asphalt pavement, and concrete pavements shown on the north side of the facility within this Alternate Bid. Assume latex track coatings. All other scope items are unchanged. Price shall be lump sum.

ALTERNATE BID

Alternate #3 – Add “Apron” Pavement on West end of Track Below New Fencing: Provide the differential cost to add “apron” pavement below fencing on the west end of the track only. Base Bid for the west condition is lawn below new fencing. All other scope items are unchanged. Price shall be lump sum.

Alternate #4 – Upgrade Track Expansion area from Latex to Polyurethane Coatings: Provide the differential cost to enhance the expansion-only area contemplated in Alternate #2 from latex to polyurethane coatings. All other scope items are unchanged. Price shall be lump sum.
