NOTICE TO ALL PLAN HOLDERS OF RECORD:

All bidders are instructed to read and to note the following described changes, corrections, clarifications, omissions, deletions, approvals and statements pertinent to the Contract Bid and Construction Documents. The following addendum items modify, change, delete from or add to, the requirements of the contract documents for this project. The articles contained in the addendum take precedence over the requirements of the previously published contract documents. Where any article of the contract specifications or any detail of the contract drawings is modified or any paragraph, subparagraph or clause thereof is modified or deleted by the articles contained in this addendum, the unaltered provisions of that article, paragraph, subparagraph or clause shall remain in effect. All Contractors shall acknowledge receipt of this Addendum in the space provided in the Bid Proposal Packet.

This Addendum No. 01 is issued in accordance with the provisions of "The General Conditions of the Contract for Construction", Article 1, "Construction Documents" and becomes a part of the Contract Documents as provided therein. This Addendum includes:

Item No. 1 - Clarifications and General Information:

1. The pre-bid sign in sheet is attached to the end of this addendum.

Project One-Roof Work

2. The layer of batt insulation between the existing shingles and new metal roof panels is eliminated from the scope.

Project two-Wall Work

3. All exterior wall work at Vinton Elementary School is to take place during the summer while school is not in session.

- 4. The last day of the 2023/2024 school year is tentatively May 22 and the first day of the 2024/2025 school year is August 6.
- 5. Roof protection is required for any scaffolding that will be set on the roof. Roof protection required around the entire chimney for masonry work.
- 6. Control joint replacement on elevations D/A201 and B/A202 is to include the top and back sides of the short masonry wall at the building entrance.

Work for Project One is to be Substantially Complete on or before October 31, 2024. Work for Project Two should be Substantially Complete by August 5, 2024. Substantial Completion is defined as the work as described in the contract documents is 100% complete."

REMOVE section 9.1.2 in its entirety and **REPLACE** it with

"9.1.2 It is the intent of the Owner to have Project One Final Completion of the Work, this would include all punch list items and all required closeout paper, completed and submitted by November 22, 2024. It is the intent of the Owner to have Project Two Final Completion of the Work, this would include all punch list items and all required closeout paper, completed and submitted by August 31, 2024."
