Pre-bid Meeting Discussion: This is the first time the College has used Workday to host a project for bid. All contractors are encouraged to verify they have access to Ivy Tech's workday site, can log-in, and understand upload requirements well in advance of the Bid Due date.

Q1: Will there be summer courses in the space?

A1: No

Q2: Will the owner be responsible for clearing out furniture in work area?

A2: Yes

Q3: Does the Construction Drawings have specifics on the Owner provided headwall equipment?

A3: The equipment legend is on A9.1A. A full equipment schedule with manufacturer and model number specifics will be provided to the awarded contractor.

Q4: Will the new drywall in the unfinished storage room converted to the Skills Lab Room D215 go to deck?

A4: Yes, per the wall legend on A2.1A full height walls to underside of deck should be provided.

Q5: Will there be a staging area on site for dumpsters?

A5: Yes, an area on the North Side of the building for dumpsters and parking can be arranged with the awarded contractor.

Q6: Is there a freight elevator for contractor use?

A6: No, the passenger elevator closest to the scope of work may be used by the contractor. There are also three adjacent staircases. Contractor is fully responsible for protecting the elevator, stairs, and corridors from damage.
