INVITATION TO BIDDERS

The Owner will receive bids for the Construction of Project, and all related accessories, in Elwood, Indiana all in accordance with the Construction Drawings and Specifications. **Bids will be received until 4 p.m. local time, on May 6, 2024, in the Clerk-Treasurer's Office, City Hall, 1505 S B Street, Elwood, Indiana 46036**. Bids received after that time will be returned unopened.

All bids will be publicly opened and read aloud at the Board of Public Works meeting at 6 p.m. local time, on May 6, 2024, at the Birch Bayh Senior Center, 715 N 19th Street, Elwood, Indiana 46036.

The work shall consist of, but is not limited to, the construction of an expansion of the raw water detention tank, and all other work necessary for and included in the Construction Documents for the City of Elwood WTP Improvements as prepared by Whitaker Engineering, McComas/O'Donnell & Naccarato, and NEO Engineers.

The Proposal must be made on the forms provided in the Contract Documents. The Bidder must supply all the information required by the bid proposal form. Each bid shall be accompanied by a cashier's or certified check, drawn on an acceptable bank, or an acceptable bidder's bond, in an amount not less than five percent (5%) of the total amount of the bid, payable to the City of Elwood, Indiana. The bidder to whom a contract for work is awarded will be required to furnish a Performance, Maintenance and Payment Bond executed on the specified forms and acceptable to the Owner, in the amount of one hundred percent (100%) of the Contract.

Partial payment will be made monthly. The Contractor and all subcontractors will be required to comply with required Federal and State labor regulations including Equal Employment Opportunity, Non-segregated Facilities, Minimum Wage Rates, and Affirmative Action requirements.

Bids may be held by the Owner for a period of not to exceed sixty (60) days from the date of the opening of the bids for the purpose of reviewing the bids and the investigation of the qualifications of bidders, prior to awarding of the Contract. The Owner reserves the right to reject any and all proposals and to waive technicalities.

A pre-bid conference will be held at 10:00 AM local time on April 16, 2024, at the Elwood P Street Water Treatment Plant, located at the intersection of S P Street and S 28th Street, Elwood, Indiana. **Drawings and Specifications will be available on or after April 1, 2024.**
