- The Project is a public bid project.

- The Project is tax exempt.

- The Bid Form needs to be filled out completely and include all items listed on the bid checklist.
- The Project contains a Contingency Allowance that is to be included in the base bid.
- A Bid Bond and Performance and Payment Bond are required on the project.
- Drawing and Specifications are available from Eastern Engineering at 1239 Wells Street, Fort Wayne, Indiana.

 - \$400 [deposit] for hardcopy.

 - o Requests for substitutions must be presented during the bidding process.
 - NO SUBSTITUTIONS will be considered after bids are received.
- The existing building is wood framed construction with metal structural columns and open web wood
 trusses
- Most of the existing walls remain in place. Coordinate between the Demolition Floor Plan and Architectural Floor Plan.

- All existing casework is to be removed.
- All sinks except for toilets rooms, and breakrooms are to be removed and water and drains capped inside
 the walls. The new breakroom sink is to be connected to the existing water and drain lines
- There will be a new sink is the conference room. This is a DEDUCT ALTERNATE. Refer to drawings for additional information.
- Toilet fixtures are to be removed to remove existing flooring and install new flooring. Contractor is to provide new wax ring when reinstalling existing toilet fixtures.
- ALL existing suspended ceiling, grid, lights, diffuser, grilles, vent fans, etc., are to be removed. The only
 light fixture to be salvaged and reused is the pendent fixture in the lobby. Refer to drawings for additional
 information.
- New exterior windows will be installed. Refer to the plans for additional information.
- The proposed ship ladder and dumbwaiter was discussed and mentioned as alternates. Refer to the drawings and specifications for additional information.
- Most of the existing doors are to be salvaged to be reused and reinstalled into H.M. frames with new hardware. Study the plans and door schedule for additional information.
- Existing doors that remain in their existing location will receive new hardware.
- The main entrance aluminum doors are being replaced in the existing frames with new hardware. Refer to the door schedule and specifications for additional information.
- The interior vestibule doors are being replaced in the existing frames with new hardware. Refer to the door schedule and specifications for additional information.
- The existing exterior H.M. doors are being replaced in the existing frames with new hardware. The existing frames need to be modified to power door hardware. Frame modification occurs on the interior of the exterior walls. Refer to the door schedule and specifications for additional information.
- Be aware of the DEDUCT ALTERNATES. Refer to the drawings and specifications for additional information.
- Existing electrical receptables that are not being reused are to be vacated and covered with a cover plate. See electrical drawings for additional information.
- Card readers, Ai phones, security cameras, buzzer releases, etc. shall be provided and installed by the owner. Data wiring, pulling and cable management shall be provided and installed by the owner.
