ALTERNATE #2 DESCRIPTION: Complete demolition of the Locker Room Addition east of Column line A and all related piping and ductwork above and below ground, as noted on sheet G1.1. Patch and Infill Masonry on east wall to match existing as required.

ALTERNATE #3 DESCRIPTION: Complete demolition of the Locker Room building south of the Gym and complete demolition of all piping, ductwork and mechanical equipment in the Mezzanine and Pool treatment room, as noted on sheet G1.1. Provide end wall enclosure from grade to parapet as noted.

ALTERNATE ADD #3 _____ dollars

ALTERNATE #4 DESCRIPTION: Complete demolition of the classroom building east of column line C at the northeast corner of the building; including all piping, ductwork and mechanical equipment, as noted on sheet G1.1. Provide end wall enclosure from grade to canopy and restore canopy that wraps existing angle iron to match original building condition from 1967.
