The following clarifications, amendments, additions, revisions, changes, and modifications change the original Contract Documents only in the amount and to the extent hereinafter specified in this Addendum.

ITEM NO. 1. PROJECT MANUAL, SECTION 23 05 00 - COMMON WORK RESULTS FOR HVAC

- A. Replace 1.1, A., as follows:
 - A. Warranties, closeout procedures, and submittal requirements are specified in Division 01 Sections.
 - 1. Warranties for Base Bid A Mechanical Equipment Procurement shall begin on the date of substantial completion as established by the delivery of equipment to the project site.

ITEM NO. 2. PROJECT MANUAL, SECTION 23 09 00 - HVAC DIRECT DIGITAL CONTROLS

- A. Add 2.5, C., as follows:
 - C. Acceptable manufacturers for actuators are as follows:
 - 1. Belimo

ITEM NO. 3. PROJECT MANUAL, SECTION 23 74 13 – PACKAGED, OUTDOOR CENTRAL STATION AIR-HANDLING UNITS

- A. Replace 2.6, A., as follows:
 - "A. Roof Curbs: Internally reinforced roof-curb units capable of supporting superimposed live and dead loads, including equipment loads and other construction indicated on Drawings; with welded or mechanically fastened and sealed corner joints, straight sides and integrally formed deck-mounting flanges at perimeter bottom.
 - 1. Materials: Zinc-coated (galvanized) or aluminum-zinc alloy coated steel sheet, 0.052 inch thick (18 gauge), minimum in mill finish.
 - 2. Overall height: Minimum of 16 inches but as required for top of curb to be 12 inches above surrounding roof material.
 - 3. Insulation: Factory insulated with 2 inch thick, minimum, polyisocyanurate board insulation.
 - 4. Liner: Same material as curb of manufacturers standard thickness and finish to provide a sealed curb perimeter.
 - 5. Nailer: Factory-installed wood nailer under top flange on side of curb, unless otherwise indicated, continuous and concealed around curb perimeter.

- 6. Platform Cap: Where portion of roof curb is not covered by equipment, provide weathertight platform cap formed from 3/4 inch thick plywood covered with metal sheet of same type, thickness, and finish as required for curbs.
- 7. Metal Counterflashing: Manufacturer's standard removable fabricated of same metal and finish as curb.
- 8. Existing conditions shall be verified by equipment supplier and installation contractor.
- 9. Extend size of curb assembly as required to comply with structural framing requirements indicated on Drawings.
- 10. Manufacturer: LM Curbs or equal.

ITEM NO. 4. REVISED DRAWING SHEETS

A. Drawing Sheets: MD.03, M.401, M.501, M2.03, M3.03, and M3.11 have been revised, dated 10/30/24 and are included with and hereby made a part of this Addendum. These Drawings supersede the original documents.

ITEM NO. 5. DRAWING SHEET S1.01

A. Framing Plan: Revise roof curb note to read as follows:

"Roof Top Unit shall be provided with a roof curb assembly sufficient strength to distribute weight of RTU equally to (3) roof joists. The roof curb assembly shall be a minimum of 9'-6" long to bear across a minimum of (3) roof joists as shown."

> Alternate Bid No. 1: Remove existing louvers associated with unit ventilators and other mechanical equipment. Infill existing wall construction with new wall construction as noted and detailed on the drawings.

Base Bid: Existing louvers associated with unit ventilators and other mechanical equipment to remain in place with a new insulated blank-off panel and construction as noted and detailed on the drawings.

- 4. <u>Identification of Submission of Bid Proposal</u>: Per the Instructions to Bidders, the Bid Proposal shall be submitted in an envelope identified with the name of the project, name of the bidder, base bid package, and the date and closing time of bids. No work shall occur on-site while students are in school. Last day of school is **May 29**, **2025**. All Work must achieve Substantial Completion and be operational by **August 8**, **2025**. Students return to school on approximately **August 13**, **2025**. Owner will need to perform their cleaning and set-up of each classroom once Work is complete by the Contractor, prior to August 8, 2025. The schedule for the Work will be confirmed at the Preconstruction Meeting referenced above.
 - All contractors are advised that this Contract may require multiple labor shifts and overtime to accommodate the Scope of Work within the Project Schedule.
 - b. Refer to Project Manual Section 01 10 00, Summary, Article 1.3 Work Covered by Contract Documents.
- 7. <u>Temporary Facilities and Controls</u>: Information on temporary facilities and controls are listed in Section 015000 of the Project Manual.
