


### Snider High School Doors 4 and 5





- O & M Manuals: Require separate tab for each building, all in one binder.
- Heat-Welding sheet vinyl: note the installer qualifications.
- Some Owner Furnished Material.
- Attic stock not typical. Take Note for each material in the spec.
- Custom base size in a few locations plan for longer lead times.
- Score along top of existing base before removal so as not to pull any paint or drywall off.
- Detailed keyed notes on plans—check first before asking questions.



- In all rooms that contain carpet, full tiles shall be utilized with the outside corner of the carpeted area being the starting point for layouts of carpet and tile. Any need for cut tiles shall occur along the walls but do a test-to-fit before installation ensuring this does not create a sliver along wall or at doorways. Carpet tile shall be installed to the nearest full tile.
- All toe kicks containing existing base shall be replaced with new.
- All owner provided material shall be picked up from FWCS storage facility.
   FWCS will not have a forklift or pallet jack available.





- Explain floor levels at Forest Park (First Floor vs. Basement).
- There is no base on the built-in bookshelves at Northside HS.
- Final clean of dance floor at **Snider** is by flooring contractor.










- FWCS's Procore Online system to submit and track:

- 1. If visiting a school, be at the school by 4:00 so office staff can let you in. If school is closed and no students or staff, contact the Custodial Manager. The phone number is in the spec book. This Friday 11/8 no school.
  - a. Visiting Forest Park is highly recommended given the unique conditions of each of the staircases.
- 2. Address to pick up owner stock flooring is 1627 S. Calhoun Street 46802 (back east parking lot).
- 3. Do not use trash cans in the classrooms.
- 4. FWCS has a pallet jack at Murray Street, but if used, there is no lift to get FWCS existing stock product up on a flatbed.
- 5. Include contingency in bid.
- 6. FWCS will help with phasing and which order of schools to start.
- 7. Contractors to provide adhesive for owner provided stock flooring.
- 8. Forest Park gymnasium does not have base except for a couple of small area. Remove base but do not install new base. Clean adhesive off surfaces.
- 9. Dance floor sample and sales rep business card available for attendees to view.
- 10. It was stated in the meeting that a new Bid Form would be issued removing Franke Park Door #1 from Alternate 2. **Post-meeting correction**: a new Bid Form will <u>not</u> be issued. Acknowledgement of change in alternate will be assumed with listing that Addendum #1 containing the change has been received.
