BID DUE DATE

- Bids will be due at 2:00 p.m. local time on Thursday, March 13, 2025 at the Administrative offices of Kokomo School Corporation, 1500 South Washington Street, Kokomo, IN 46902.
- 2. The bids will be **publicly** opened and taken under advisement for review and recommendation by the **Owner and Engineer.**

DESCRIPTON OF PROJECT

This Package consists of One Base Bid project, and 4 Alternates. The scope for Base Bid is for full tear-off of the existing Fully adhered EPDM roof system and replacement with new fully adhered EPDM roof system on various areas at Kokomo High School. The scope for Alternate One is for the removal of existing EPDM Roofing system and replace with a fully adhered EPDM membrane system on various areas at Lafayette Park Elementary School. The scope for Alternate Two is for the removal of existing EPDM Roofing system and replace with a fully adhered EPDM membrane system on various areas at Lafayette Park Elementary School. The scope for Alternate Two is for the removal of existing EPDM Roofing system and replace with a fully adhered EPDM membrane system on various areas at Maple Crest School. The scope for Alternate Three is for the removal of existing EPDM Roofing system and replace with a fully adhered EPDM membrane system on various areas at Darrough Chappel Head Start. The scope for Alternate Four is for the installation of new metal soffit panels on the main entrance canopy at Darrough Chappel Head Start.

INSTRUCTION TO BIDDERS

- 1. Please take note of the public bidding requirements in the Instructions to Bidders and in the Supplementary General Conditions.
- It is asked that all questions and /or requests be addressed directly to Etica Group in writing, by e-mail at (<u>smettert@eticagroup.com</u>) prior to Friday, March 7, 2025 at 5:00 pm. The answers, qualifications, or information noted during this meeting or during phone conversations that differ from the bidding documents are not to be considered official unless noted in an Addendum.
- 3. No Bidder, after the award of the Contract, shall be allowed any extra compensation for any reasons of their failure to inform themselves fully of the project prior to their bidding, of all the project's requirements, Contract Documents and circumstances of the building site.

- 4. A Bid Security of **5%** or a certified check made out to **Kokomo School Corporation** for **5%** of the bid amount is required with the bid.
- 5. Items bidders must considered when preparing their bid.
 - a. The cost of a Performance and Payment Bond of **100% included in** the contractor's bid is required.
 - b. The successful bidder must provide a Certificate of Insurance with Kokomo School Corporation listed as the additional insured, and this must meet or exceed the insurance requirements outlined in the project specifications.
 - c. The school corporation's tax-exempt number will be provided to the successful bidder.
- 6. For consideration, a Bid Form must be submitted in duplicate, sealed in an envelope, and delivered to the administration building by the designated time. The clock in the board room will be used as the "official" clock for determining when receipt of bids will be closed.
- 7. Bids must be submitted on the State Board of Accounts Form 96-Revised 2013 and Supplementary Bid Form provided in the project manual.
- 8. All Bids shall be guaranteed for 60 days.
- 9. Take note that, in the event of any inconsistency between the drawings and specifications or within either document that is not clarified by addendum, the better quality or greater quantity shall be provided.

CONTRACT INFORMATION

1. The Owner/Contractor Agreement will be AIA document A101 2017 Edition.

- 6. Contractor will be able to begin preparation of submittals and project planning immediately upon receiving the "Award Letter" which will serve as the "Notice to Proceed". A preconstruction meeting will be required with the Owner and Engineer before construction work can begin.
- 7. All work may begin following the 2024/2025 School year, which is tentatively May 28, 2025
- 8. Substantial Completion July 31, 2025

SPECIAL NOTES

- 1. Kokomo School Corporation's facilities and grounds are TOBACCO FREE SITES. This means that the use of any tobacco products (including e-cigarettes and vapes) on the school property is prohibited.
- 2. Contractors wishing to make follow-up visits to the building must contact Mr. Chad Shepherd to set up a time. Do not attempt to visit the site or building without prior arrangements or permission from the Owner.

SUPPLEMENTARY GENERAL CONDITIONS:

- 1. Financial irresponsibility or past record of failure to perform any work as determined by the Owner shall be a valid reason for the Owner's objection to any proposed subcontractor by the Contractor.
- 2. The successful Contractor will be required to establish an escrow account at a banking institution approved by the Owner, however, if the Owner agrees, the Contractor may elect to have the Owner hold retainage. The Owner however, will not be required to, nor will they, pay interest on the retainage it holds.

SUMMARY GENERAL

1. Owner will maintain access and occupy all sites during construction. The Contractor is to coordinate/communicate any/all possible disruptions to the Owner's operations.

CONTINGENCY ALLOWANCE

1. A contingency Allowance of \$7,500 is to be included in the Roofing Base Bid, and \$7,500 is to be included in each of the Alternates One - Three Roof Work at Lafayette Park Elementary School, Maple Crest School, and Darrough Chapel Head Start.

EPDM ROOFING

1. Products specified are Carlisle Sure-Seal A FR and Elevate Rubbergard Max.

SHEET METAL

- 1. Specified premanufactured fascia is WP Hickman Ecosnap, and Metal Era Perma-Tite System.
- 2. The Contractor may shop fabricate fascia, however the shop-fab fascia must be ANSI-SPRI ES-1 certified.
- 3. Soffit panels are to be Flush Solid Soffit panels.
