Documents issued March 24, 2025 for **Request for Architect / Engineer (AE) Services for On-Call Projects 2026-2030** are hereby revised as indicated.

ITEM 1. RFP Amendments

- 1. Reissue Request for Proposal pages 13-14, 17-18, 21-22, 25-26, 29-30, and 33-34 to reflect allowance adjustment from Addendum 1 and Question 4 from Addendum 2.
- 2. Contract Revisions
 - a. Article 1, Item 1.7
 - i. Substitute CAD for Revit for Projects I, III, IV, V, and VI.
 - b. Schedule A, Items 2.8, 3.12, 4.7
 - i. Remove the following sentence from each section, as reviews will be through the Owner's Bluebeam account;
 - 1. Printing/Reproduction costs of all review documents will be borne by DESIGN PROFESSIONAL and shall not be considered a reimbursable expense.
 - c. Schedule A 4.7.1
 - i. Remove the following language;
 - 1. one (1) printed copy in a 3 ring binder and

ITEM 2. Questions and Answers

- 1. Are the allowances in each project per year (i.e., \$2,500 each of the 5 years)?
 - The allowances are for each bid package per year. If there are multiple bid packages pursued under each RFP project a reimbursement allowance will be assigned accordingly.
- 2. For the Project V work in the past, we just used aerials from GIS to produce documents for those projects. Is that acceptable or do we need to get sites surveyed?
 - a. Site surveys are not anticipated as a part of Project V. It is anticipated that the A/E on Project V would be able to work through outlining minor grading adjustments for stair, ramp, walk, stoops, and other site elements replacements through field verification methods.
- 3. For the Project VI work, there will most likely need to be a survey for these types of projects. Is the survey provided by owner or is that fee part of the reimbursables?
 - a. Owner direct cost.



4. This line in the proposal was unclear. We are giving a percentage for our fee. What is this "Lump Sum Fee Proposal" for?

- 5. In Addendum 1, Proposal Requirements, Part B Submittal: Fee The Fee Proposal Form (RFP Section 00006), Rate Schedule (RFP Section 00007), and Attachments A-D. Attachment A is the 42-page contract, do you want this attached and filled out in its entirety?
 - a. No need to include Attachment A. Please include Attachments B-E.
- 6. For the On-Call Projects RFP, could you provide further clarification on the intended breakdown of the project location count? For example, the 2-10 project range in the \$0-\$600,000 range, would this be:
 - 1) Five projects whose combined construction value is equivalent to \$600,000 or less (example: five \$100,000 projects for a total of \$500,000)?
 - 2) Five projects that each have a value of \$0-\$600,000, but could have a total value greater than \$600,000 (example: five \$200,000 projects for a total of \$1,000,000)?
 - a. The Project Location Count is defined as the number of buildings or sites included as part of the bid package. For example, a future project that is a \$450,000 bid package at a single building may have a different fee than a \$450,000 bid package including work at 8 buildings or a \$450,000 bid package including work at 15 buildings.

All other provisions of this Request for Proposals remain unchanged.
